- 5) **“Wakiil ganacsade** (commercial agent)” waxa loola jeeda shaqsi ama shirkad loo wakiishay inuu u metalo ganacsade mulkiile ah ama shirkad ugana wakiil noqdo meel gaara ama dalka oo dhan ama qayb ka mida awoodihiisa fulinta hawlo ganacsi iyo/ama gelidda heshiisyada khuseeya ganacsiga loo wakiishay;
- 6) **“Shirkad”** waxa loola jeedaa shirkad lagu aasaasey ama loo diiwaan-galiyay si waafaqsan Xeerka Shirkadaha Somaliland ee Xeer Lr. 80/2018;
- 7) **“Shuraako** (partnership)” waxa loola jeeda ganacsi ay ku bahooben laba ganacsade ama in ka badan loona aasaasey si waafaqsan Xeerka Ganacsiga Guud ee Somaliland;
- 8) **“Ganacsi hal-mulkiile ah** (Sole proprietorship)” waxa loola jeedaa ganacsi uu leeyahay hal qof oo dabiici ah (natural person) isla markaana aan ahayn shirkad shakhsiyad jiritaan qaanuuni ah leh;
- 9) **“Mihnad Cayiman”** waxa loola jeedaa xirfadlayda sida bahda caafimaadka, dawo-yaqaanka (pharmacists); dhakhaatiirta, xirfad yaqaanada muraayadaha indhaha, lataliyeyaasha ganacsiga iyo dhaqaalaha; garyaqaanada, hantidhawrada, xisaabiyeyaasha iyo qof kasta oo kale oo ku shaqaysta xirfad aan sharciyaysnayn qofna loo



ogoleyn in uu ku shaqaysto ilaa uu ruqsad ka haysto hay'ad awood u leh mooyee;



- 10) **“Ruqsad”** waxa loola jeedaa wargad ogolaansho hawl-qabad oo ay bixisay hay'ad ama wasaarad awood u lehi si waafaqsan xeerkan iyo xeerarka kale ee ay khusayso iyadoo loo siiyay si uu u dalbado liisanka ganacsi ee khuseeya shaqadaas;
- 11) **“Liisan ganacsi”** waxa loola jeedaa liisan ama shati loo bixiyay ama loo cusboonaysiiyay si waafaqsan Xeerkan;
- 12) **“Liisan ganacsi dhaqangal ah”** waxa loola jeeda liisan ganacsi loo bixiyay si waafaqsan xeerkan oo aysan ka dhicin mudada dhaqangalnimada liisanka ganacsi ee ku cad Qodobka 11aad ee Xeerkan ama aan lagala noqon si waafaqsan Xeerkan iyo xeerarka kale;
- 13) **“Soodajiye”** waxa loola jeedaa ganacsade liisan ganacsi u haysta inuu badeecad ama adeeg kasoo dhoofiyo dal dibadeed oo uu keeno Somaliland;
- 14) **“Dhoofiye”** waxa loola jeedaa ganacsade liisan ganacsi u haysta in uu ka dhoofiyo Somaliland badeecado, xoolo ama adeeg una dhoofiyo dalka dibadiisa;
- 15) **“Jumladle”** waxa loola jeedaa ganacsade u haysta liisan ganacsi in badeecadaha uu ka soo iibsado soodajiye ama wax-soosaare warshadeed uuna jumlad ahaan kaga sii iibiyo ganacsade tafaariiqle ah, haydaha dawladda, hay'adaha aan dawliga ahayn ama iskaashatooyin;



- 16) **“Tafaariiqle”** waxa loola jeedaa ganacsadaha haysta liisan tafaariiqayn ee wax ka soo iibsada ganacsadaha jumladaha ah kuna sii iibiya xaddiga ugu yar ee laga isticmaalo badeecaddaas;
- 17) **“Kormeere”** waxa loola jeedaa masuulka ay hay’adda liisan bixintu u xilsaartey ama u magacawdey kormeeridda, kor-joogteynta iyo hubinta in hawlaha ganacsigu waafaqsan yihiin Xeerkan iyo xeerarka kale ee dalka JSL;
- 18) **“Hay’adda liisan bixinta”** waxa loola jeedaa wasaaradda u xilsaaran ganacsiga iyo dawladda hoose oo leh awoodda bixinta liisamada ganacsiga sida ku tilmaaman qodobka 5aad ee xeerkan;
- 19) **“Hay’adda ruqsad bixinta”** waxa loola jeedaa hay’ad dawladeed oo uu sharci gaar ahi awood u siiyay bixinta ruqsad khuseysa nooc ganacsi oo uu sharcigu waajib kaga dhigayo ganacsadeha in uu ruqsad u haysto ka hor inta aanu dalban ama aanu qaadan liisanka ganacsi ee ku waajibay;
- 20) **“Golayaasha Deegaanka”** waxa loola jeedaa goleyaasha heer degmo ee lagu dhisay si waafaqsan Dastuurka iyo Xeerka Goboladda iyo Degmooyinka Somaliland, Xeer Lr. 23/2019;
- 21) **“Wasaaradda”** waxa loola jeedaa wasaaradda u xilsaaran ganacsiga;

Ujeedooyinka Xeerkan waa:-

1. In la dajiyo nidaam cad oo ku dhisan hufnaan iyo daahfurnaan oo loo raaco bixinta liisamada ganacsiga isla markaana ah nidaam si fudud u gaadha ama ay u heli karto cid kasta oo ganacsato ahi ama danaynaysa **in ay ka qayb qaadato ganacsiga Somaliland.**
2. In la xoojiyo korna loo qaado kalsoonida ay ganacsatada iyo maalgashadeyaashu ku qabaan hay'adaha dawliga ah iyo nidaamyada sharci ee khuseeya ganaciga Somaliland;
3. In la qeexo waajibaadyada iyo masuuliyadaha hay'adaha dawladeed ee u xilsaaran bixinta liisamadaga ganacsiga.

## Qodobka 4aad

### Xadka Dabaqidda Xeerkan

- 1) Xeerkan waxa lagu dabaqayaa dhammaan liisamada ganacsiga ee kala ah:
  - a) Liisamada ganacsiga baayacmushtarka (merchandising business licensing) ee dhoofinta, soodejinta ama dhoofinta iyo soodejinta, ganacsiga jumladlaha ah iyo ganacsiga tafaariiqhlaha ah;

- A) Beerafalashada, dhaqidda xoolaha ama dhir beeridda aan ujeedo ganacsi laga lahayn ee loo sameeyo si loogu noolaado.

#### **Awooda Bixinta Liisamada Ganacsiga**

- 1) Liisamada ganacsiga baayacmushtarka (**merchandising business license**) ee soodejinta ama dhoofta ama labadaba, iyo liisanka ganacsiga jumladlaha ah (wholesaler) waxa bixinaysa Wasaaradda.

Wasaarada iyadoo loo raacayo Foomka Gudsiga Liisanka sida ku cad Lifaaqa 1aad ee Xeerkan.



- 3) Liisamada ganacsiga ee ku xusan Faqradda 2aad ee Qodobkan, ee la xidhiidha wax-soosaarka warshadaha iyo adeegyada shirkadaha ganacsiga waxay Wasaaraddu bixinaysaa kadib marka ay shirkadahaasi ka helaan ama ka soo qaataan ruqsaddii ogolaanshaha hawlqabad ee wasaaradaha ama hay'adaha ay khusayso si waafaqsan xeerarka khuseeya ee la xidhiidha ogolaanshaha ruqsadahaas.
- 4) Liisamada ganacsiga baayacmushtarka **(merchandising business license)** ee ganacsatada Tafariiqalaha ah **(Retail Trader)** ee aan ahayn kuwa ku xusan faqradaa 1aad ee qodobkan waxa bixinaya Dawladaha Hoose.
- 5) Liisamada ganacsiga hal-mulkiilaha ah (sole proprietorship) ee aan ahayn kuwa ku xusan faqradda 2aad ee qodobkan, ee ay leeyihiin ganacsatada muwaadiniinta ama ajaanibka ah ee ganacsigoodu la xidhiidho xirfadaha iyo adeegyada ku taxan Lifaaqa 2aad (B) waxa bixinaya Dawladaha Hoose.

### **Qodobka 6aad**

#### **Ogolaanshaha iyo ku Shaqaysiga Liisamada Ganacsiga**

- 1) Ganacsadena dalka Jamhuuriyadda Somaliland kama qaban karo hawlo ganacsi haddii aanu u haysan liisan ganacsi dhaqangal ah oo loo siiyay si waafaqsan Qodobka 5aad ee xeerkan.

- 2) Ganacsadena laba ganacsi ama in ka badan oo kala duwan kuma wada yeelan karo isla hal goob ganacsi, hadii uuna ganacsi kasta gaarkii ugu haysan liisanka ganacsi ee khuseeya.
- 3) Ganacsadaha haysta liisan ganacsi oo dhaqangal ah, ee soo dejinta ama/iyo dhoofinta ama liisanka ganacsiga wax-soosaarka warshadaha ama liisamada ganacsiga adeegyada ee ay bixiso wasaaraddu, waxa uu laamo ganacsi oo kale dalka gudhiisa ku furan karaa liisankaasi uu haysto.
- 4) Ganacsadaha liisan ganacsi u haysta soo-dajiyee waxa loo ogol yahay in uu goobta ama xarunta ganacsigiisa uu badeecadda uu soo dajiyay **jumlad** ahaan ugaga sii iibiyo ganacsadeyaasha haysta liisan jumladle isagoon laga dooneynin in uu qaato ama haysto liisan **jumladle** ah.
- 5) Ganacsadaha liisan ganacsi u haysta soo-dajiyee waxa loo ogol yahay in uu goobta ama xarunta ganacsigiisa uu badeecadda uu soo dajiyay jumlad ahaan ugaga sii iibiyo ganacsadeyaasha haysta liisan jumladle ama tafaariiqle ah isagoon laga dooneynin in uu qaato ama haysto liisan jumladle ah.
- 6) Ganacsatada ku xusan Faqradaha 4aad iyo 5aad ee Qodobkan, hadii ay tafaariiq ku iibiyaan waxsoosaarkooda ama badeecadaha ay soo dejiyaan, waxa ku waajiba inay qaataan liisanka tafaariiqda ee ay dawladaha hoose bixiyaan.

- 2) Haddii codsadhaha liisamada ganacsiga ee ku xusan Faqradda laad ee Qodobkani uu yahay ganacsade soodajiye ama/iyo dhoofiye, ama jumladle, ama warshadle, ama adeeg bixiye ah shirkad ganacsi, ama shuraako ama iskaashato, waxa uu foomka codsiga liisanka ganacsi ku soo lifaaqayaa faah-faahintan:
  - a) Magaca iyo ciwaanka codsadhaha.
  - b) Magacyada iyo aqoonsiga saamilayaasha iyo maamulayaasha shirkadda oo ay la socdaan laba sawir oo kur ah oo uu leeyahay saamiile kasta ama maamule kasta.
